AUGUST MEETING



Deborah Earl is a founding member of the Power2Parent Executive Board and currently serves as Vice President. She received her bachelor's degree in English from Brigham Young University. Deborah is passionate about education and believes that parental involvement in education is the number one indicator of success in a child's education. Deborah has written several articles for the Las Vegas Review Journal championing issues that affect families in Nevada. She has been a guest on the Alan Stock Show and served on committees in the Clark County School District to support

parental voice in policy decisions. Deborah and her husband Cameron reside in Las Vegas with their 5 children.

She encouraged our members to attend school board meetings, to read the books that are given children and to speak up on issues. She remarked public schools are fine, but you need to be vigilant that studying is done.

In the summer of 2014, founder of Power2Parents Erin Phillips attended an invite only CCSD meeting where a graphic sexuality education curriculum was introduced, suggesting kindergarteners be taught about topics like masturbation. She was appalled. Shortly after that, a group of parents gathered in someone's living room and began to discuss the need for an organized effort to expose the degradation of parental rights. An organization that could inform, organize, and mobilize parents and community members to protect parental rights.



Today Power2Parent has grown in more than 7 years from a small group of parents to one of the most influential parents' rights groups in Nevada and now in several other states in the country. Power2Parent is a national organization. Last October they formed a national Parent Union and are building an army of parents and concerned community members to channel their voices so that parents can effectively advocate for their children. They are taking education back from government interests and self-interested teachers unions.

Their efforts to inform and organize parents in meetings and hearings has stopped bad policy and exposed dangerous agendas from groups who do not believe you should have the right to parent your children the way you see fit. In the 2017 legislative session, they stopped a Planned Parenthood backed bill aimed at taking away your right to know when your child would be taught sexuality education. They are working hard every day to monitor and hold people accountable for attempting to circumvent your fundamental right to parent.

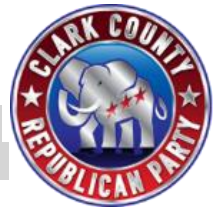

We highly recommend you sign up to get their updates to stay informed on key legislative actions and breaking issues. To be a voting member of the Nevada Republican Central Committee (NCRCC) you must first be a member of the CCRCC and be elected from this group to the state central committee.

All of these groups will welcome you to attend their meetings, receive their newsletters, volunteer in their various outreach programs and of course—DONATE cash to support their efforts.

CCRCC meetings typically meet the third Tuesday every other month. Of course, nothing has been typical in the past year and they've been very constrained by the Governor's meeting mandates. You may sign up on the website by completing a new member application (<https://clarkgop.org/application.html>). You will then receive notices from the CCRCC and can attend the next meeting, although voting privileges are not established until the second meeting. The CCRCC mission is:

- Increasing Republican voter registrations.
- Identifying, recruiting, and supporting Republican candidates for office.
- Establishing ongoing efforts to raise money to promote Republican candidates.

- Concentrating on grass roots efforts in local communities
- Participating in community functions so the Republican brand is better
- Increasing Republican voter turnout by increasing voter awareness, reaching out to voters and provide rides when necessary.

This Task Force has been established. A timeline was presented to the Board of Trustees at the August 26th Board meeting. The Task Force will produce a first draft the policy in October with final adoption proposed for January.

It should be noted that School Board heard an hour and a half of public comments before the CCSD meeting on August 26th. Most of the speakers were urging the school district to take action.

The task force has a diverse membership from a wide range of areas of the CCSD. Should be interesting to read their first draft.

At the June 24th meeting the CCSD Staff provided the Board with an update on the Anti-Racism Policy Development Work. The update included:

- Public Interest Anti-Racism Policy Form
- Criteria for External Anti-Racism, Equity, and Inclusion Taskforce
- Professional Experts
- Anti-Racism Policy Development Website
- NextSteps:

Establish external Taskforce for policy development. Taskforce participation will include:

- Equitable, Inclusive, and Diverse Representation
- Experience and Expertise
- Community Involvement and Impact

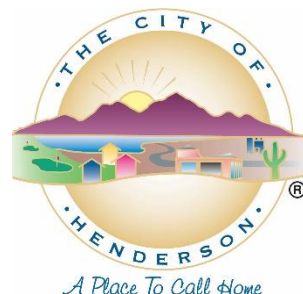
Using the criteria above the Taskforce will be made up of 25 external individuals who responded to a public interest form that closed on June 11, 2021. The Taskforce will

also include internal CCSD staff members that will work in conjunction with the external Taskforce members.

Craig Smith report on Henderson City Council meeting

August 17, 2021 City Council Meeting:

Zach Conine, Nevada State Treasurer provided a presentation to the City Council regarding the American Rescue Plan Act. Following is an overview:



The State of Nevada is receiving over \$3.7 billion in federal funding from the Coronavirus State and Local Fiscal Recovery Fund. More than \$1 billion of these funds are being distributed directly to local governments. The remaining \$2.7 billion is being allocated to the State to respond to the impacts of the COVID-19 pandemic, bring jobs back and lay the foundation for a strong recovery.

In April 2021, the Every Nevadan Recovery Framework was published, laying the groundwork for how the State will organize and plan the spending of its share of the federal funding from the Coronavirus State and Local Fiscal Recovery Fund created by the American Rescue Plan Act. This infusion of federal dollars presents a once-in-a-lifetime opportunity for the State and local governments to collaborate and implement longstanding ideas and projects that will effectuate positive long-term change for every resident of Nevada and Clark County.

According to the presentation there are:

Four bands of prioritization:

1. Nevadans' Basic Needs
2. Community
3. Economy
4. Quality of Life

Seven priorities for strategic enhancement

1. Increasing Access to Healthcare and Community-based Services
2. Strengthening Public Education
3. Supporting Disadvantaged Communities
4. Strengthening Nevada's Workforce, Supporting Small Businesses and Revitalizing the Economy
5. Investing in Infrastructure
6. Modernizing and Enhancing State Government Services
7. Addressing Budget Shortfalls

Next:

- Step 1: Statewide listening tour to collect stakeholder input and community feedback on the effects of the pandemic and what programs and services would best aid in recovery.
- Step 2: Listening tour input is collected and summarized into comprehensive Roadmap.
- Step 3: After finalizing Roadmap, State will move to designing and creating new programs and services that will be funded through ARP.
